### **Tax Policy and Budget 2013**

1. An oral presentation was given to the Group, summarising the Programme for Government commitments in relation to tax, the recent consultations that have taken place and the policy adjustments that have been made from 2009-12.

### **Selected VAT Issues**

**(TSG 12/04)**

2. The paper on selected VAT issues reviewed the VAT rates and structure and discussed options for possible change. The paper also examined VAT issues at domestic level and concluded by summarising VAT developments at EU level.

### **Economic Framework for Budget 2013**

**(TSG 12/03)**

3. The Economic paper was presented to the Group and gave an update on the current economic situation and the emerging macroeconomic outlook. The paper looked at the external environment, latest domestic developments, economic outlook 2013-15, risks to the forecasts and set out the views of the Department of Finance in relation to Budgetary policy.

### **Residence Issues**

4. The paper on residence issues examined the taxation issues which relate to the residence of individuals, with a particular focus on so-called “tax exiles”. It covered the issues likely to arise in the context of Budget and Finance Bill 2013, the commitment in the Programme for Government, recommendations made by the Commission on Taxation and also the recent consultation process on the residence of individuals for tax purposes.
