

Report of Tax Strategy Group Meeting on 25th September 2012

Minutes of the meeting on 18th September 2012 (TSG 12/05)

1. The minutes of the meeting of the 18th September were agreed.

Summary of Farm Taxation reliefs (TSG 12/08)

2. The paper covered taxation issues relating to farming and agriculture, it outlined that there are a number of taxation expenditure measures which are exclusively aimed at the farming community and that farmers can also avail of number of other expenditure measures which are not exclusive to that sector. The paper set out the current position and examined issues that have been raised, or are likely to arise, in the context of the Budget and Finance Bill 2013 and the Programme for Government.

Pay-Related Social Insurance Changes (TSG 12/07)

3. This paper set out the principal policy issues relating to any consideration of PRSI changes in Budget 2013. It reviewed developments in recent Budgets in relation to both PRSI income and expenditure measures and outlined the role of the social insurance system generally in providing social protection. The key findings of the recently published Actuarial Review of the Social Insurance Fund were detailed. The paper identified the primary policy options available to ensure the sustainability of the Social Insurance Fund in the years ahead and included a wide range of possible income-raising measures to address the current funding shortfall.

Income Tax (TSG 12/06)

4. This paper set out the Programme for Government commitments in relation to income tax. It then summarised developments in Budget 2012 before outlining policy considerations for Budget 2013. The paper concluded by making comparisons between the Tax Wedge in Ireland and that in other OECD states.
